1 INTRODUCTION

Thank you for purchasing NeedleOff. This manual is written for the end user and contains instructions and descriptions to ensure safe installation, use and maintenance of the product.

Before using the product, make sure to read and fully understand the contents of this manual and always follow all safety instructions.

1.1 INTENDED USE

NeedleOff is exclusively intended as a mobile removal and storage device for straight mounted, uncapped and threaded (metric and imperial) dental needles. The product is designed for singlehanded use only. The product can only be used with the accompanied Sharptainer. Without the Sharptainer in place, the product will not function.

Please carefully read the instructions for use before using your product for the first time. Store this manual close to the product for future reference. Sharpfield Company cannot accept liability for non-compliant product use.



Warning! Incorrect use of the product may cause injuries.

1.2 UNINTENDED USE

Do not use NeedleOff for any type of needle other than a straight, threaded (metric and imperial) dental needle. It is not designed for other needles (such as Luer-Lock), needles that are mounted to the syringe under an angle (such as Citoject) or devices that don't offer unobstructed access to the needle hub (such as Quicksleeper).

Removal of incompatible needles should not be attempted and use with incompatible devices should be avoided, as it can cause severe damage to the product.

Never empty a used Sharptainer. The integrated RFID chip will always remember the number of procedures performed with the Sharptainer. The product will no longer function with a Sharptainer that has reached the maximum number of procedures.

Do not dispose of any other materials into the Sharptainer. This can fill up the Sharptainer without increasing the procedure count and lead to unsafe situations; for example when needles can no longer fit in the Sharptainer. It can also result in having to replace the Sharptainer before the procedure count limit has been reached.

Do not insert a capped needle into the entry funnel of the product.

2 PRODUCT DESCRIPTION

NeedleOff is a portable device with built-in battery that safely removes and stores used dental needles from syringes. NeedleOff allows you to comply with the global ban on recapping contaminated needles and significantly lowers the danger of needlestick injuries and contamination.

The removed needles are automatically dropped in a secure Sharptainer that can safely hold up to 400 needles. The number of performed removal procedures is shown on the display of the product and is stored on the RFID chip in the Sharptainer. The number of procedures will be remembered even after removing and re-inserting the Sharptainer. When a Sharptainer is full, the lid of the Sharptainer can be permanently sealed to ensure safe transportation and disposal of the contents.

2.3 ENVIRONMENTAL CONDITIONS

NeedleOff is designed to be safe at least under the following conditions:

- Indoor use;
- Altitude up to 2,000 m;
- Ambient temperatures between 5 40 °C;
- Max relative humidity of 80% at <31 °C, with a linear decrease to 50% at 40 °C;
- Mains supply voltage fluctuation of ± 10% of the nominal voltage;
- Transient overvoltages up to levels of overvoltage Cat II*;
- Temporary overvoltages occurring on the mains supply;
- · Applicable pollution degree of the intended environment**.

3 SAFETY

Always follow the following safety instructions when using NeedleOff.

3.1 USE



Danger! Working with contaminated needles comes with risks. The user should always be aware of the dangers, take safety precautions and use personal protection measures (e.g. gloves, mask, protective glasses) to avoid contamination.



Danger! Never open the product housing yourself. There's risk of serious injury or death. Opening the housing will void your warranty.



Danger! After the needle has been removed, do not reuse the syringe. This eliminates the risk of cross-contamination. Make sure the syringe is cleaned in accordance with the applicable hygiene protocol for contaminated medical instruments before the next use.



Danger! Dental needles contain approved anesthetics for human use and are contaminated with biological substances when used. When using NeedleOff to detach the contaminated needle, both substances are considered to be transferred to the device, hence contaminating the device. Make sure NeedleOff is cleaned in accordance with the Maintenance procedures before the next use, or replace the Gripper Cassette.



Warning! Incorrect use of the product may cause injuries.



Warning! This product is intended for indoor use by medical professionals only.



Warning! Although it is possible to remove a slightly bent needle from a syringe using the product, it results in an increased risk of obstruction of the entry funnel. The procedure to clear the entry funnel is potentially unsafe and increases the risk of needlestick.



Warning! Never stick your finger in the entry funnel. If there is a needle stuck in the funnel, you may get needlestick



Warning! Never use your free hand to hold NeedleOff in place during a removal procedure to avoid needlestick.



Warning! Do not apply any downward force while inserting or holding the syringe.



Warning! Do not let go of the syringe while the removal procedure is in progress.



Warning! Do not pull out the syringe while the removal procedure is in progress.



Warning! Trying to remove the syringe while it is being held by the Gripper Cassette will severely damage the product.



Warning! Never manually open the Sharptainer lid.



Warning! Do not insert foreign objects into the entry funnel. The sensors may be triggered when activating the mechanism, which could result in injury and severe damage to the product.



Always place the product on a flat, stable surface before use.



Always keep the product upright to avoid needles from falling out of the entry funnel or blocking the Gripper Cassette.



In case the needle is not properly removed from the syringe (e.g. if you don't hold the syringe during the procedure), the syringe will remain stuck in the entry funnel. Do not try to forcefully remove the syringe. After 5 seconds, the syringe with needle will be released and can be removed with care. You can repeat the removal procedure. Keep in mind that the needle can already be partially loosened during the first removal procedure.



After removal from the product, the Sharptainer is automatically closed but not yet sealed.



If the display shows "No Sharptainer", the Sharptainer has not been inserted properly or is not in place. Remove the Sharptainer and carefully try again until the displays shows "IN".



Every procedure performed by NeedleOff will be registered by the display procedure counter, even if the procedure fails to remove the needle (e.g. if you don't hold the syringe during the procedure).



This charger should only be used with the NeedleOff device. Only use this original charger to power the NeedleOff device. Do not replace any part of the charger with third party spares.

3.2 MAINTENANCE, STORAGE & DISPOSAL



Danger! Dental needles contain approved anesthetics for human use and are contaminated with biological substances when used. When using NeedleOff to detach the contaminated needle, both substances are considered to be transferred to the device, hence contaminating the device. Make sure NeedleOff is cleaned in accordance with the Maintenance procedures before the next use, or replace the Gripper Cassette.



Warning! Always turn off and unplug NeedleOff before performing any maintenance or removing the Sharptainer or Gripper Cassette. Removing the Gripper Cassette before turning off the product could trigger a sensor causing NeedleOff to start a removal procedure.



Warning! Do not immerse the product, power cord, charger or any of its other parts or consumables in water or any other liquid. Do not place the product or any of its parts/consumables in a dishwasher.



Warning! Always follow the local rules and regulations regarding the disposal of contaminated sharps.



Warning! Always store the product in a dry place at room temperature. Avoid placing the product in direct sunlight for extended periods of time.



If the product is not used for a longer period of time, it is advised to charge the device regularly to ensure it can be used whenever necessary.

4 USE

4.1 CHARGE THE BATTERY

The battery of the product is only partially charged out-of-the-box. Before the first use, make sure to fully charge the battery. To charge the battery:

- 1. Plug the DC power supply into the charging port (1) of the product.
- 2. Plug the other side of the DC power supply into a working power outlet.

The display ① will show a mains icon ⑥ to indicate that the product is plugged in. While the battery is charging, the battery icon around the mains icon is empty. The battery icon is filled when the battery is fully charged.

When the product is running on battery power, the display shows a full battery icon to indicate the full charge. Battery power will decrease with every procedure. The battery level indicator uses two steps to show the power decrease (half full & empty).

When the battery has insufficient power to safely remove a needle, the battery level indicator will show as empty. The product will no longer be able to start a new removal procedure. Regardless of this safety feature, it's advised to be extra cautious whenever the battery level indicator shows half full, as the risk of incomplete removal increases. Please recharge the device as soon as possible.



It is possible to use the product while continuously plugged into the mains. This way, low battery issues will be prevented.

4.2 POWER ON

Turn on the device by switching the power switch ① to the 't' position. If a Sharptainer in place, the Display shows "IN" to indicate the product is ready for inserting a needle. When no Sharptainer has been placed or is not correctly inserted, the display shows "No Sharptainer".

4.3 INSERT A USED SYRINGE WITH NEEDLE (IMAGE B + C)



Danger! Working with contaminated needles comes with risks. The user should always be aware of the dangers, take safety precautions and use personal protection measures (e.g. gloves, mask, protective glasses) to avoid contamination.

NeedleOff is designed to be operated using just a single hand to insert the syringe without the need to hold the product itself with your free hand.



Warning! Never use your free hand to hold NeedleOff in place during a removal procedure to avoid needlestick.

 Place the product on a stable surface (e.g. your worktop) in the treatment room. This way the needle can be removed right after the final injection. This prevents unnecessary risk of contamination by handing over or moving with the contaminated needle.



Always place the product on a flat, stable surface before use.

- 2. Firmly hold the syringe so that it cannot turn in or slip from your hand.
- Carefully insert the uncapped needle into the entry funnel and firmly hold the base of the syringe to prevent it from spinning during the procedure. See image B.

The removal procedure starts automatically and the display shows "HOLD" to indicate the procedure is in progress. See image C.



Warning! Do not apply any downward force while inserting or holding the syringe.



Warning! Do not let go of the syringe while the removal procedure is in progress.



Warning! Do not pull out the syringe while the removal procedure is in progress.

4.4 REMOVE A USED SYRINGE WITHOUT NEEDLE (IMAGE D)

When the procedure is finished, the display shows "**OUT**" to indicate it is safe to remove the syringe. The Gripper Cassette will firmly hold the needle.

 Carefully remove the syringe from the entry funnel in a calm and fluent motion. Visually confirm if the needle has been successfully removed from the syringe.

Once the sensor registers that the syringe has been removed, the needle will be released into the Sharptainer. The procedure counter (a) will increase by 1 and the display shows "IN" to indicate the product is ready for a new procedure.



Danger! After the needle has been removed, do not reuse the syringe. This eliminates the risk of cross-contamination. Make sure the syringe is cleaned in accordance with the applicable hygiene protocol for contaminated medical instruments before the next use.



Warning! Trying to remove the syringe while it is being held by the Gripper Cassette will severely damage the product.



In case the needle is not properly removed from the syringe (e.g. if you don't hold the syringe during the procedure), the syringe will remain stuck in the entry funnel. Do not try to forcefully remove the syringe. After 5 seconds, the syringe with needle will be released and can be removed with care. You can repeat the removal procedure. Keep in mind that the needle can already be partially loosened during the first removal procedure.



Every procedure performed by NeedleOff will be registered by the display procedure counter, even if the procedure fails to remove the needle (e.g. what can happen if you don't hold the syringe during the procedure).

4.5 REPLACE THE SHARPTAINER (IMAGE E)

When the Sharptainer reaches 250 procedures, the procedure counter (s) will blink to indicate it is no longer quaranteed to have a safe removal of needles due to blockage by previously removed needles.

After 400 performed procedures, the display shows "FULL" and NeedleOff stops functioning until the Sharptainer is replaced by a new Sharptainer. To remove the Sharptainer:



Warning! Always turn off and unplug NeedleOff before performing any maintenance or removing the Sharptainer.

1. Visually ensure that there is no needle stuck in the entry funnel.



Warning! Never stick your finger in the entry funnel. If there is a needle stuck in the funnel, you may get needlestick

- 2. Hold the base of the Sharptainer by the indentations on the side.
- 3. Gently pull the Sharptainer forwards.

When the Sharptainer is removed from the product, the Sharptainer lid (3) will automatically close off the opening. The display will show "No Sharptainer".



Warning! Never manually open the Sharptainer lid.



After removal from the product, the Sharptainer is automatically closed but not yet sealed.

Insert a new Sharptainer or a Sharptainer that has not yet reached 400 procedures. The Sharptainer lid will automatically open when inserted into the product.

When the Sharptainer is inserted correctly, the display will show "IN" and the procedure counter will show the amount of procedures performed with the new Sharptainer.



If the display shows "No Sharptainer", the Sharptainer has not been inserted properly or is not in place. Remove the Sharptainer and carefully try again until the displays shows "IN".

4.6 SEAL THE SHARPTAINER (IMAGE F + G)

The Sharptainer can be permanently sealed for secure transportation and disposal. To seal a Sharptainer:

- 1. Tear off the Sharptainer lid sealing strip (12)
- 2. Push the lid forward until you hear a clicking sound.

The Sharptainer is now sealed and cannot be opened anymore, nor be used in NeedleOff. It is now safe to transport and dispose of the Sharptainer.



Warning! Always follow the local rules and regulations regarding the disposal of contaminated sharps.

4.7 REPLACE THE GRIPPER CASSETTE (IMAGE H + J)

The Gripper Cassette is subject to wear and should be replaced periodically. To replace the Gripper Cassette:



Warning! Always turn off and unplug NeedleOff before performing any maintenance or removing the Gripper Cassette. Removing the Gripper Cassette before turning off the product could trigger a sensor causing NeedleOff to start a removal procedure.

1. Visually confirm that there is no needle stuck in the entry funnel.



Warning! Never stick your finger in the entry funnel. If there is a needle stuck in the funnel, you may get needlestick

- 2. Press the lid lock (4) to unlock the lid (2) and carefully tilt the lid backwards.
- 3. Gently squeeze the cassette clamps (8) together and pull the cassette out of the product.
- 4. Push in a new cassette until you hear it clicking into place.
- 5. Close the lid until you hear it clicking into place.
- 6. Turn the device back on.

5 MAINTENANCE

5.1 PERIODIC MAINTENANCE

NeedleOff doesn't require a lot of maintenance. However, regular and thorough cleaning of the product is advised.

For cleaning purposes, the Gripper Cassette can be easily removed from the product (see §4.7 – "Replace the Gripper Cassette" for instructions). Make sure you have at least one spare Gripper Cassette readily available. This ensures uninterrupted operation in case a Gripper Cassette requires cleaning after use.

Clean the Gripper Cassette with alcohol, a cloth and a small brush. The entry funnel can be removed from the cassette for easy cleaning.

Clean the product housing with a moist cloth or alcohol wipes.



Danger! Dental needles contain approved anesthetics for human use and are contaminated with biological substances when used. When using NeedleOff to detach the contaminated needle, both substances are considered to be transferred to the device, hence contaminating the device. Make sure NeedleOff is cleaned in accordance with the Maintenance procedures before the next use, or replace the Gripper Cassette.



Warning! Always turn off and unplug NeedleOff before performing any maintenance or removing the Sharptainer or Gripper Cassette. Removing the Gripper Cassette before turning off the product could trigger a sensor causing NeedleOff to start a removal procedure.



Warning! Do not immerse the product, power cord, charger or any of its other parts or consumables in water or any other liquid. Do not place the product or any of its parts/consumables in a dishwasher.

For safety reasons, the battery can only be accessed by a qualified repairman. To replace the battery, please contact Sharpfield Company.

6 STORAGE

Turn the device off before storing it:

• Switch the power switch 10 to the '0' position to turn off the device.



Warning! Always store the product in a dry place at room temperature. Avoid placing the product in direct sunlight for extended periods of time.



If the product is not used for a longer period of time, it is advised to charge the device regularly to ensure it can be used whenever necessary.

7 TROUBLESHOOTING

"No Sharptainer" is displayed.	No Sharptainer has been placed in the product or the Sharptainer is not properly placed.	Follow the steps from the §4.5 - "Replace the Sharptainer".	
"RFID error" is displayed.	The Sharptainer has no contact with the product.	Turn the product off and on again.
